II. Agenda Items

1. Downtown Christmas Plans

- DDA President Ken Land presented:
- Introduced a Christmas initiative for December
- Goal: Increase downtown foot traffic and boost economic development
- Concept: Create a Hallmark movie-like atmosphere
- Plan involves partnering with local businesses and the DDA
- Extensive lighting and decorations proposed
- Requested city partnership for the project

2. Strategic Plan Update

- City Manager Richard Newbern presented:
- Updated strategic plan for August 2024 through August 2026
- Includes five main goals: personnel, technology, infrastructure, quality of life, and city services
- Department heads to develop work plans based on this strategy
- Work plans to be presented at the September 10th meeting
- Quarterly reports from department heads planned

3. Property Tax Report

- City Manager Richard Newbern reported:
- Provided update on outstanding property taxes
- Deadline for clearing delinquent taxes: August 23rd
- Unpaid taxes to be published in newspaper on September 5th
- Estimated tax sale date: October 1st
- Fewer than five residents claimed to have paid with cash but couldn't find receipts

4. Waste Management Residential Services

- Public Works Director Willie Farrow reported:
- New Thursday pickup service implemented
- Some mechanical issues occurred on Tuesday and Wednesday pickups, quickly resolved
- Communication between dispatch and city hall needs improvement

5. Department Head Reports

A. Police Department - Chief Jeff Trawick:

- Presented monthly report
- Noted discrepancies due to new software system implementation
- Discussed increased patrols around McVay Heights Apartments

B. Fire Department - Chief Brock Wilcher:

- Announced city's upgrade to ISO Class 4 effective November 1st
- May result in lower insurance rates for property owners

C. Public Works - Director Willie Farrow:

- Discussed ongoing CDBG housing projects
- Introduced new code enforcement officer Samantha Burns
- Reported on asbestos removal and floor damage in municipal annex building

D. Finance Department - Director Bonie Raffield:

- Reported auditors working on trial balances for city accounts
- Audit completion goal: December 31st

Ash Street Park Project

Engineers Adam Price and James Jones from Falcon Design presented:

- Detailed plans for playground equipment, pavilion, restroom facilities
- 860-foot walking trail proposed
- Extensive landscaping plans discussed
- Estimated timeline: potentially open by spring
- Discussion of possible irrigation system as bid alternate
- Consideration of lighting plan as potential addition

- Water meter replacements
